## National CO-OP Month

October is national co-op month. We celebrate our community coming together in 1937 and forming Big Horn REA to provide reliable and affordable electricity to you.

### How is Your Co-op Different?

As October is National Co-op Month, Big Horn Rural Electric would like to educate and inform you, our member-owners, a little bit about co-ops. One item we would like to educate you on is the difference between a cooperative and an independently owned utility (IOU). The following seven principles describe why you should be proud to say you're a member of Big Horn REA.

- One: Voluntary & Open Membership**  
Cooperatives, like Big Horn Rural Electric Co., are voluntary organizations, open to all persons able to use their services and willing to accept the responsibilities or membership, without gender, social, racial, political or religious discrimination.
- Two: Democratic Member Control**  
Cooperatives are democratic organizations controlled by their members, who actively participate in setting their policies and making decisions. Big Horn's board of directors is comprised of its members and is elected by the membership. Members have equal voting rights – one member, one vote.
- Three: Members' Economic Participation**  
Members contribute equally to, and democratically control, the capital of their cooperative. Big Horn was established to provide at-cost electric service. Our net margins above expenses and reserves belong to the members and are called capital credits. These capital credits are reinvested in poles, wire and other elements of our system for a period of time before they are refunded to the members.
- Four: Autonomy and Independence**  
Cooperatives are self-governing organizations controlled by their members. If Big Horn enters into agreements with other organizations, including governments, or raise capital from external sources, we do so on terms that ensure democratic control by our members and maintain our cooperative autonomy.
- Five: Education, Training and Information**  
Cooperatives provide education and training for their members, board members, managers and employees so they can contribute effectively to the development of their cooperatives. They inform the general public – particularly young people and opinion leaders – about the nature and benefits of cooperatives. Big Horn educates its members through the use of the monthly "Highlights" newsletter and its website.
- Six: Cooperation Among Cooperatives**  
Cooperatives serve their members most effectively and strengthen the cooperative movement by working together through local, national, regional and international structures. Big Horn is a member of the Wyoming Rural Electric Association and National Rural Electric Cooperative Association.
- Seven: Concern for Community**  
While focusing on member needs, cooperatives work for the sustainable development for their communities through policies accepted by their members. Big Horn invests in our communities through Youth Leadership Camp, scholarships, economic development and safety demonstrations.

winter or snag a deal on an end-of-season lawn mower or weed trimmer, Big Horn offers up to 50% off the purchase price (\$100-\$300 per item) of these battery-powered tools. This includes electric snow blowers, lawn mowers, weed trimers, chainsaws and just about any outdoor power tool on the market. These rebates are good for equipment purchased locally or online and each account can get up to \$600 in incentives. *Looking to upgrade your kitchen?*

Big Horn REA offers a \$700 rebate for an induction cooktops or induction ranges in new construction or homes that are replacing gas or propane cooking appliances. Induction cooktops not only cook faster, but are safer for your family. The cooking element stays cool to the touch and because it's electric, there isn't potential for gas leaks. If you already have an electric range or cooktop, we will still provide an incentive of \$200 for switching to an

induction cooktop.

*Are you worried about the cost of propane and heating your home this winter?*

Modern air source heat pumps now operate efficiently in cold climates. A properly sized, and installed air source heat pump can make your home more comfortable while reducing your energy spend. Ask your contractor or look for models with a SEER greater than 17 or HSPF greater than 9.5 and Big Horn will rebate 50% of your equipment costs up to \$900 per ton. For heat pumps below 17 SEER, we will provide a rebate of \$600 per ton. Another benefit of heat pumps is they cool your home while filtering air in the summertime. So, while you may not need air conditioning, heat pumps can improve your indoor air quality on smoky summer days.




# Manager's Message

Thanks to all those who completed the survey that had recently been mailed to each member. The completion of the survey was one of the objectives to help accomplish the Strategic Planning Goal of Expand Member Engagement. Some of the items noted were: --- not everyone is aware of the rebates that is offered on electric products; most everyone agrees the employees provide excellent customer service; there is an interest in renewable energy; and communicating with members is important.

And speaking of communicating it was interesting to note the number of responses relative to rates and costs. Big Horn and our power supplier

(Tri-State Generation & Transmission) strive to be efficient in our operations and control costs. In fact, Big Horn has not had a rate increase since January 2017. That is nearly four full years without an increase to your electric bill! I am confident that there is probably not one product that you use on a daily basis and one that provides value to your way of living like electricity does that has not increased in four years. While the prices for such things as: vehicles; fuel; insurance; materials and other items needed for the day to day operations of Big Horn have increased, Big Horn has not increased the rates. Better yet, in response to a few questions from the survey wondering what will the

rates do in the next year, Big Horn does not project a rate increase in the year of 2022.

There were also questions relative to our power supplier, renewable energy, the electric grid, and climate change. You will have the opportunity to hear from the CEO of Tri-State Generation & Transmission as Big Horn will be hosting a "town hall meeting". See article in this newsletter.
