

REBATE CHANGES? YES, YOU HEARD THAT RIGHT!

As part of our commitment to our members, Big Horn REA along with our power supplier Tri-State Generation & Transmission, is proud to offer rebates! There will be a few changes when it comes to the rebates.

The timeframe will remain the same, you must submit your itemized receipt that clearly shows detailed product make & model information, associated labor costs, consumer name, date and verification of purchase/payment unless otherwise noted within 90 days of purchase.

Big Horn REA as well as Tri-State reserves the right to modify and/or stop this program at any time.

The 50% Big Horn match will remain the same.

After submitting the rebate, there is a preliminary incentive that is calculated when the application form is complete. Please note that this amount is only an estimate and may vary from the actual rebate payment based on application review and calendar year. The actual rebate amount will reflect the value for the calendar year in which it is submitted. Rebate calculations will not be modified to reflect the prior year's incentives.

Tri-State will send a single rebate payment to Big Horn for all approved Electrify and Save incentive applications during a specific period. Big Horn will then send out checks.

REBATE CHANGES? YES, YOU HEARD THAT RIGHT!

- Electric heat pump: Air-Source (ducted, ductless & radiant)
 - Base Tier EnergyStar version 6.1 minimum standard 7.8 HSPF2
 - \$250/ton, up to 5 tons.
 - \$125/ton for additional capacity over 5 tons.
 - Ductless Cold-Climate EnergyStar version 6.1 cold climate 8.5 HSPF2, 70% capacity and COP of 1.75 at 5°F
 - \$500/ton, up to 5 tons.
 - \$250/ton for additional capacity over 5 tons.
 - \$1,000/ton rebate for Low-to-Moderate income.
 - Ducted Cold Climate—EnergyStar version 6.1 8.1 HSPF2, 70% capacity and COP of 1.75 at 5°F
 - \$500/ton, up to 5 tons.
 - \$250/ton for additional capacity over 5 tons.
 - \$500 bonus for base and cold climate tier ducted systems with propane.
 - \$1,000/ton rebate for Low-to-Moderate income.
 - Air to Water Heat Pumps
 - \$500/ton, up to 5 tons.
 - \$250/ton for additional capacity over 5 tons.
 - Equipment manufacturer and model number identification.
 - Itemized receipt, including breakout of equipment and labor.

Incentive amount is the lower of stated rebate or 50% of equipment

- Electric heat pump: Ground-source
 - New ground source heat pump systems and replacement heat pumps are eligible.
 - \$500/ton for new installations.
 - \$250/ton for existing unit replacement.
- **Electric vehicle chargers**
 - Photo of installed EVSE equipment and circuit in service panel required.
 - Level 2(L2)—No retail sale or free collection capability.
 - 50% of total equipment and installation. costs up to \$250 for non-managed chargers.

BIG HORN REA RATES (EFFECTIVE 1-1-24) (PREVIOUS RATES)

After careful consideration from board and staff the below table outlines the changes in rates which became effective January 1, 2024. The rates show an overall average rate increase of approximately 9.45 percent. In conjunction with Big Horn's power supplier Tri-State Generation and Transmission's rate increase of 7 percent which also became effective January 1, 2024 and the ever-increasing cost of operations, Big Horn's financials have been impacted. Your board and staff will continue to work diligently in managing costs.
